#### **Continuing Professional Development (CPD) Diary**

As a professional, there is an ongoing commitment to maintain and enhance professional skills and knowledge.

CPD is expected of registered veterinarians in all States and Territories in Australia. All jurisdictions have agreed, through the Australasian Veterinary Boards Council (AVBC) and the Australian Veterinary Association (AVA), that the **minimum** is 60 points over a rolling three year cycle.

The *Veterinary Practice Act 2003* requires NSW registered veterinarians submit an Annual Return. In the Annual Return **points** regarding CPD must be supplied to the Board.

The following pages provide a guide to the National Points System.

The CPD requirement is based on a minimum of **60 points over three consecutive years**, of which, **at least 15 points must be structured** points. The remaining 45 points may be unstructured points or more structured points.

This diary can be used to assist in recording your activity and corresponding points scoring.

The points system is the same as the AVA and you may prefer to use their recording system. The AVA does NOT forward points onto the Board on your behalf.

Only the **points gained during the 12 month return period (1 April to 31 March)** are to be recorded in the **Annual Return**. Activity validation needs to be kept by the practitioner for possible future reference. Do **not** return the CPD Diary or validation documentation.

#### \*Postgraduate courses in veterinary science related to the chosen field of work

A veterinarian who is completing formal post-graduate training with a view to the acquisition of a higher qualification in their chosen field of work or a related area of veterinary science, is considered to be fulfilling all the requirements for continuing education. In this situation you may simply choose to report 15 structured points and 45 unstructured points for the year in which you gain this qualification.
